Budget and Advocacy AEA and ARD continue to work with the BAC. We are pleased to report that President Obama’s 2016 budget proposal included an increase for the core programs in research and Extension at the 1890 land-grant universities. The proposed increases appear to be sufficient enough to accommodate the addition of Central State University as an 1890 land-grant university without adversely impacting the current funding being allocated to the existing 1890 institutions. The 1890 Universities have now established a new website – www.1890universities.org . It is continuously being updated and strengthened. It will serve as a collaborative website that markets and brands the 1890s. The ARD continues to communicate with the 1890 universities through its website and its monthly newsletter, the <i>ARD Updates</i> . The ARD website is primarily a functional site and can be immediately updated through the ARD Executive Director. The new 1890 website has been lacking the link to on-line giving and it is hoped that link is functional soon. The ARD continues in the financial support of consortia and seed grants. The Food Safety consortium, funded by the ARD, was awarded a Capacity Building Grant from NIFA in the area of food safety for \$600,000. This new food safety team will host a mini symposium at ARS in Beltsville, MD on April 1 – 3, 2015 and conclude with a meeting of the ARD as they discuss the procedure to be used to fund the next ARD consortium and how to facilitate the sustainability of the Food Safety consortium. <p>125th Anniversary of the Second Morrill Act</p> <p>The signature events will be held in Library of Congress buildings in Washington, DC in 2015. There will be exhibits on the Hill, hearing(s) and the signing of a proclamation by the House Agriculture Committee are proposed, and there will be a convocation. These events have been scheduled for July 15-16, 2015 while Congress is in session. We will also have a national “1890 Day” celebrated on all 1890 campuses and extended into state counties with the assistance of Extension on April 23, 2015.
