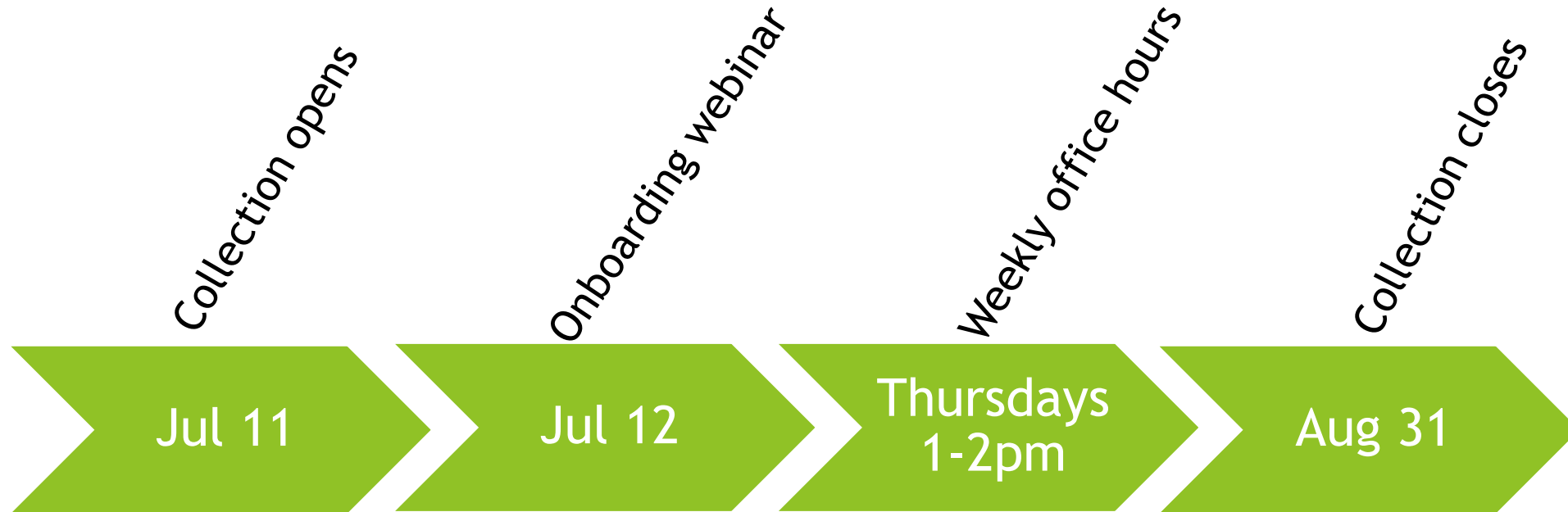

- ▶ Completion rates at other institutions after 6 years - Fall 2015 cohorts
- ▶ Enrollment status at the home institution after 6 years - Fall 2015 cohorts
- ▶ Enrollment status at another institution after 6 years - Fall 2015 cohorts
- ▶ Status unknown after 6 years - Fall 2015 cohorts

Overview of submission process

Submit 15 cohort files to the NSC's cohort query

Receive institutional files from NSC

Upload 15 institutional aggregate cohort reports to the secure CDM portal

Update institutional metrics in the Annual Metrics Template

Upload CDM Template to the secure CDM portal

NSC's cohort query

- ▶ Go to NSC's Student Tracker page:

 - ▶ See the Cohort Query Guide or the Sample Cohort Query Report to learn how to upload files
- ▶ Upload 15 Fall 2015 cohort files to NSC's secure portal
- ▶ For each cohort, NSC processes the data (within hours) and returns an Aggregate Cohort Report with 5 institutional metrics
 - ▶ Completion rates at the reporting institution
 - ▶ Completion rates at other institutions
 - ▶ Enrollment status at the reporting institution
 - ▶ Enrollment status at another institution
 - ▶ Status unknown
- ▶ Submit 15 Aggregate Reports to the secure CDM Portal
