RE: Request to Extend OMB's March 19 Memo M-20-17

Dear Ms. Weichert,

The Council on Governmental Relations, the Association of American Universities, the Association of Public and Land-grant Universities and the Association of American Medical Colleges are four of the leading organizations representing research institutions. Our members collectively conduct a substantial amount of the nation's federally-funded research each year.

Our community continues to be extremely appreciative of the flexibilities provided for in [M-20-17](#), "*Administrative Relief for Recipients and Applicants of Federal Financial Assistance Directly Impacted by the Novel Coronavirus (COVID-19) due to Loss of Operations.*" M-20-17 has provided a sound basis for federal agencies to release agency-specific COVID-19 related guidance to the grant community, and significant relief for institutions grappling with a quickly evolving landscape in which they must make decisions and provide guidance to their research teams.

While we understand these exceptions are time limited, and that these flexibilities will be reassessed on or before June 17, ***we strongly urge OMB to extend the flexibilities outlined in M-20-17 until September 30, 2020***, to coincide with the end of the federal fiscal year and to be reassessed at the end of that period. M-20-17 already recognizes that "many of the operational impacts and costs are unknowable at this point, as they will depend on the spread of the coronavirus and response dictated by public health needs." As many states are starting to slowly reopen and research institutions are in varying stages of ramping up on-campus research across the country, this uncertainty continues to be the case. Institutions are facing unprecedented challenges in their response to this crisis, and extending the flexibilities provided in M-20-17 will help to maintain a level of consistency in this response.

Thank you for continuing to take a strong lead on this; we very much appreciate your partnership through these extraordinary times. We continue to be available to work with federal agencies and OMB to determine how best to manage this process once we are past the immediate public health emergency, and would welcome the opportunity for regular calls with OMB to discuss this situation as it continues to evolve and to help resolve any open issues as they arise.
